**ARTICLES OF ORGANIZATION
OF

The undersigned authorized agent of the initial Members of the above limited liability company hereby certifies that the Members, for the purpose of forming a limited liability company under the laws of the State of Florida, hereby execute the following Articles to provide for the formation, rights, privileges, and immunities of a limited liability company for profit. ARTICLE V

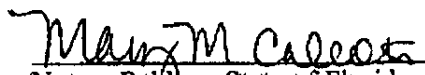
