**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF  
HOWARD BUTLER, M.D., P.A. CHANGING NAME TO  
RADIOLOGY ASSOCIATES OF THE PALM BEACHES, P.A. AND INCREASING  
NUMBER OF SHARES OF CLASS A VOTING STOCK**

In compliance with the requirements of Florida Statute Chapter 607, the undersigned does hereby file these Articles of Amendment for the purpose of changing the name of the Corporation and increasing the number of Class A voting shares.

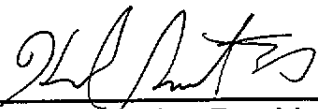
**FIRST:** Article I is amended to provide that the name of the corporation shall henceforth be: RADIOLOGY ASSOCIATES OF THE PALM BEACHES, P.A.

**SECOND:** Article IV is amended to provide that there shall be 1000 shares of Class A Voting Stock with a par value of One Dollar per share.

**THIRD:** This Amendment was adopted on June 9, 2002, and shall be effective on the date of filing with the Florida Secretary of State.

**FOURTH:** This Amendment was approved by Howard Butler, the sole holder of Class A voting shares, with a sufficient number of votes cast for approval.
