ARTICLES OF ORGANIZATION OF JUDY'S GARDENS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be JUDY'S GARDENS, LLC, ("company").

ARTICLE II - ADDRESS

The mailing address of the principal office of the Company is P. O. Box 446, Žėllwood, FL 32798. The street address of the Company is 3838 Round Lake Rd., Zellwood, FL 32798.

ARTICLE III - DURATION

The company shall be managed by the members in accordance with Operating Agreement adopted by the members for the management of the business and affairs of the company. This Operating Agreement may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.
