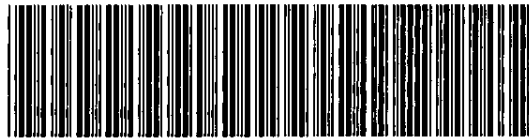

**AMENDED AND RESTATED ARTICLES OF ORGANIZATION

WHEREAS, on January 3, 2011, the initial articles of Tadeo Properties, LLC (the "Company") were adopted and filed with the Florida Department of State ("Original Articles"); and

WHEREAS, the members of the Company have determined that it is in their best interest to adopt revised articles for the Company in the form hereof; and

NOW THEREFORE, the undersigned being a duly authorized representative of the members, pursuant to the provisions of Florida Statutes Section 608.411, adopts the following Amended and Restated Articles of Organization of TADEO PROPERTIES, LLC, a limited liability company duly organized and existing under the laws of the State of Florida as filed with the Florida Department of State on January 3, 2011 (the "Amended and Restated Articles of Organization"):

ARTICLE I

NAME

The name of the limited liability company is TADEO PROPERTIES, LLC.

DURATION AND CONTINUATION

Each Manager(s), other than the initial Managers, shall be appointed or elected solely as provided in the Operating Agreement.




