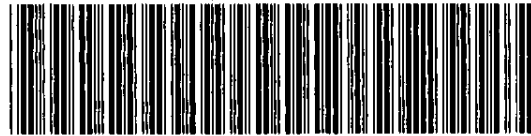

Name**
