## **ARTICLES OF ORGANIZATION for ACME HOLDINGS XI, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

### ***ARTICLE I - NAME***

The name of the limited liability company shall be Acme Holdings XI, LLC ("Company").

### ***ARTICLE II - STREET ADDRESS***

The street address of the principal office of the Company shall be 407 Wekiva Springs Road, Suite 249, Longwood, Florida 32779.

### ***ARTICLE III - MAILING ADDRESS***

The mailing address of the Company shall be Post Office Box 915888, Longwood, Florida 32791-5888.

### ***ARTICLE IV - DURATION***

The Company is to exist perpetually.

### ***ARTICLE V - PURPOSES AND POWERS***

The general purpose for which the Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida as specified in the Operating Agreement of the Company. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

### ***ARTICLE VI - MANAGEMENT***

The Company shall be managed by one (1) or more managers and is, therefore, a manager-managed company. The method of election of the Managers shall be as specified in the Operating Agreement of the Company.

### ***ARTICLE VII - INITIAL REGISTERED OFFICE AND AGENT***

The street address of the initial registered office of the Company is: 407 Wekiva Springs Road, Suite 249, Longwood, Florida 32779 and the name of the initial registered agent for service of process at that address is Robert J. Hutchins.

### ***ARTICLE VIII - ADMISSION OF NEW MEMBERS***

No additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and upon such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the Operating Agreement of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.




