ARTICLES OF ORGANIZATION
of
PRONTOPAY MOBILE LLC
(A Florida Limited Liability Company)

The undersigned, desiring to form a Limited Liability Company in the State of Florida pursuant to Florida Statute, Chapter 608, hereby certifies:

ARTICLE I - NAME

The name of the limited liability company shall be ProntoPay Mobile LLC, hereinafter referred to as the "Company".

ARTICLE II - ADDRESS

The principal street address and mailing address of the Company is 2110 NW 95th Avenue, Miami, Florida 33172.

ARTICLE III - PURPOSE

The Company is organized to conduct business for any and all lawful purposes under the laws of the State of Florida.

ARTICLE IV - MANAGEMENT

The Company shall be managed by one or more managers and shall be a manager-managed company. The number of managers may be changed from time to time in these Articles or in the Company's Operating Agreement but shall at no time be less than one. The initial managers of the Company shall be JNS Technology LLC and Shail Shah. The Operating Agreement may contain additional information or provisions concerning the management and regulation of the Company and its affairs, but shall not be inconsistent with the laws of the State of Florida or these Articles.

ARTICLE V - REGISTERED AGENT

The Registered Agent of the Company shall be Shail Shah. The address of the Registered Office is 2110 NW 95th Avenue, Miami, Florida 33172. The Registered Agent accepts this designation and agrees to comply with the provisions of Chapter 608 F.S. regarding the same.
