SECOND AMENDED AND RESTATED ARTICLES OF ORGANIZATION FOR 169 NE 2th, LLC

169 NE 2nd, LLC, a Florida limited liability company (the "Company"), certifies that:

A. The Articles of Organization of the Company were filed by the Florida Department of State on January 11, 2011, and assigned Florida document number L11000003961 (the "Articles of Organization").

- B. The Articles of Organization were amended and restated in their entirety and filed by the Florida Department of State on May 23, 2013 (the "Amended and Restated Articles of Organization").
- C. Section 2 of the Certificate of Designation of Registered Agent/Registered Office attached to and filed with the Amended and Restated Articles of Organization incorrectly identified New Maxco LLC as the Registered Agent instead of Dennis Max.
- D. The Amended and Restated Articles of Organization are hereby amended and restated their entirety to read as follows:
