ARTICLES OF ORGANIZATION  
OF  
PAYMENTEZ A HOLDINGS LLC**

These Amended and Restated Articles of Organization of Paymentez A Holdings LLC are being filed pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act and hereby replace, in their entirety, the Amended and Restated Articles of Organization of Paymentez A Holdings LLC filed with the Florida Secretary of State on February 2, 2011 (which replaced the original Articles of Organization of the Paymentez A Holdings LLC filed January 12, 2011 under Document Number L11000005145).

**ARTICLE I – NAME**

The name of the Limited Liability Company is Paymentez A Holdings LLC (the “Company”).

**ARTICLE II – ADDRESS**

The street address and mailing address of the principal office of the Company is 6460 SW 133rd Drive Miami, Florida 33156.

**ARTICLE III – PURPOSE**

The purpose for which the Company is organized is to conduct any and all lawful business permitted under Florida law.

**ARTICLE IV – MANAGEMENT**


The Company shall be managed by its sole member, Paymentez, LLC, a Florida limited liability company, and is therefore a member-managed company.
