**ARTICLES OF AMENDMENT  
TO ARTICLES OF ORGANIZATION OF  
NSC 14 SR 40, LLC**

Pursuant to the provisions of Sections 605.0202, Florida Statutes, this Florida limited liability company adopts the following:

1. The Articles of Organization ("Original Articles") of NSC 14 SR 40, LLC, a Florida limited liability company ("Company"), were filed on January 13, 2011, and assigned document number L11000005341.
2. The Original Articles were subsequently amendment pursuant to Articles of Amendment filed on January 24, 2012. The Original Articles as so amended are hereafter referred to as the "Amended Articles."
3. The Amended Articles are hereby amended as follows:
  - a. Article IV of the Amended Articles, is hereby amended to read as follows: The Company is to be managed by one or more managers and is therefore a manager-managed limited liability company. The current managers of Company are as follows: Shirley B. Rudnianyn, 2441 NE 3rd Street, Suite 201, Ocala, FL 34470, and Todd Rudnianyn, 2441 NE 3rd Street, Suite 201, Ocala, FL 34470.
  - b. A new Article VI is added to the Amended Articles to read as follows: These Articles may be amended by the affirmative vote or written consent of a majority of the membership interests in Company.
4. The Amendment set forth herein was approved by the holders of all of the membership interests of the Company. The number of votes cast for the Amendment was sufficient for approval.


