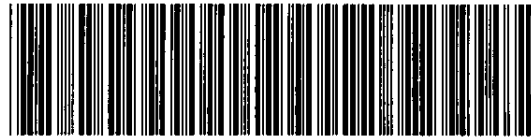

ARTICLE I - Name

ARTICLE IV - Management

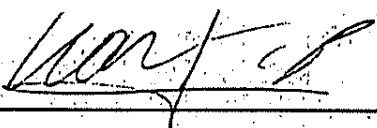
The Company shall be managed by its sole member Mentez LLC, a Florida limited liability company, and is therefore a member-managed company.
