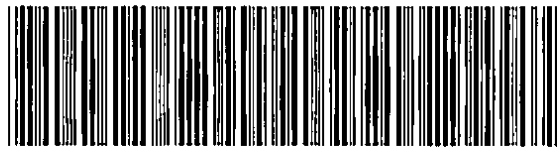

These Amended and Restated Articles of Organization of Paymentez B Holdings LLC (the "Company") are being filed pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act and hereby replace, in their entirety, the Amended and Restated Articles of Organization of the Company filed with the Florida Secretary of State August 31, 2021 and February 2, 2011 (which replaced the original Articles of Organization of the Company filed January 13, 2011 under Document Number L11000005413).

1. **Name.** The name of the limited liability company is Paymentez B Holdings LLC (the "Company").

2. **Purpose.** The purpose of the Company is to conduct any and all lawful business permitted under Florida law.
