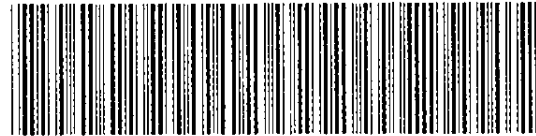

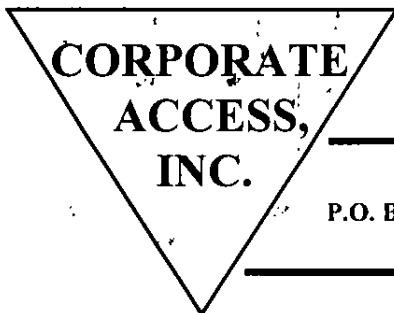

ARTICLE VIII - AMENDMENT




