## AMENDED ARTICLES OF ORGANIZATION

of

### ALEXA LOVES LLC (A Florida Limited Liability Company)

Pursuant to the provisions of Section 608.411, ALEXA LOVES LLC hereby adopts the following amendments to its Articles of Organization. The Amended Articles were duly adopted by unanimous consent of all members entitled to vote on the Amendment on November 14, 2011.

#### ARTICLE I - NAME

The name of the limited liability company shall be Alexa Loves LLC, hereinafter referred to as the "Company".

#### ARTICLE II - ADDRESS

The principal street address and mailing address of the Company is 2288 Sunset Drive, Miami Beach, FL 33140.

#### ARTICLE III - PURPOSE

The Company is organized to conduct business for any and all lawful purposes under the laws of the State of Florida.

#### ARTICLE IV - MANAGEMENT

The Company shall be managed by one or more members, and therefore is a member-managed company. The manager of the Company shall be Alexa Jacobs. The number of managing members shall be as set forth in the Operating Agreement of the Company, which number may be amended from time to time, but shall at no time be less than one. The Operating Agreement may also contain additional information or provisions concerning the management and regulation of the Company and its affairs, but shall not be inconsistent with the laws of the State of Florida or these Articles.

#### ARTICLE V - REGISTERED AGENT

The Registered Agent of the Company shall be Minott Gore, P.A. The address of the Registered Office is 201 S. Biscayne Blvd., Suite 2800, Miami, Florida 33131. The Registered Agent accepts this designation and agrees to comply with the provisions of Chapter 608 F.S. regarding the same.

The Company's duration shall commence upon the filing of these Articles with the Florida Department of State and shall continue in perpetual existence, unless earlier dissolved by operation of law or: (i) in accordance with the Company's Operating Agreement, or (ii) upon unanimous written consent of all the membership interests.

#### ARTICLE VII – AMENDMENT

These Articles may be amended only as provided by law or in accordance with the Company's Operating Agreement.

#### ARTICLE VIII – ACCEPTANCE
