**ARTICLE I  
NAME**

The name of the Limited Liability Company (the "Company") is NOT MY FAULT, LLC.

**ARTICLE II  
ADDRESS**

The mailing address and street address of the principal office of the Company is 3700 Airport Road, Suite 204, Boca Raton, Florida 33431.

**ARTICLE III  
DURATION**

The period of duration for the Company shall begin on the date of filing these Articles of Organization with the Florida Secretary of State and shall have a perpetual existence and duration, until terminated in accordance with applicable law.


