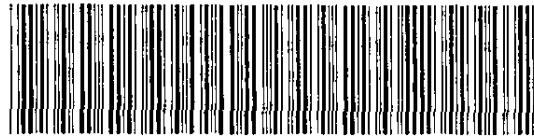

The undersigned, for the purpose of forming a limited liability company under and by virtue of the Florida Limited Liability Company Act (Annotated Code of Florida, §§4A.101 to 4A.1103) (the "Act"), does hereby file the following Articles of Organization:

1. The name of the limited liability company formed hereby is KAB Advisors LLC (the "Company").
2. The address of the principal office of the Company in the State of Florida is 4501 Gulf Shore Boulevard North, PH1503, Naples, Florida 34103.


