The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I – NAME:

The name of the limited liability company shall be "CHIEF'S ENDEAVORS, LLC" (hereinafter referred to as the "Company").

ARTICLE II – ADDRESS:


