**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION
OF
DONEGAL PROPERTIES, LLC**

The undersigned, being the sole member of DONEGAL PROPERTIES, LLC, a Florida limited liability company (the "Company"), desiring to amend the Articles of Organization of the Company originally filed January 18, 2011, pursuant to the terms of Chapter 608, Florida Statutes, the Florida Limited Liability Company Act (the "Act"), states as follows:

1. The name of the Company is DONEGAL PROPERTIES, LLC.
2. The date of the filing of the original Articles of Organization of the Company was January 18, 2011 (the "Articles of Organization") and the Florida Department of State issued the Company Document Number L11000006557.

3. Article V is hereby added to the Articles of Organization as follows:

The Company shall be manager-managed and the name and address of the initial manager of the Company is as follows:

4. Article VI is hereby added to the Articles of Organization as follows:

A Withdrawing Member shall not be entitled to receive the "fair value" (within the meaning of Section 608.427 of the Act) of the Withdrawing Member's Interest in the Company as of the effective date of withdrawal based on the Withdrawing Member's right to share in distributions from the Company or otherwise. Instead, the Withdrawing Member shall be entitled to receive the amounts, if any, as may be set forth in the Company's Operating Agreement.
