ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION

The undersigned, Manager of CLC REGAL OAKS, LLC, a Florida limited liability company (the "Company"), desiring to amend the Articles of Organization of the Company pursuant to the terms of Chapter 608, Florida Statutes, the Florida Limited Liability Company Act (the "Act"), states as follows:

1. The name of the Company is CLC REGAL OAKS, LLC.
2. The date of the filing of the original Articles of Organization of the Company was January 19, 2011 (the "Articles of Organization") and the Florida Department of State issued the Company Document Number L11000007928.
3. Article II of the Articles of Organization is amended to read as follows:

4. Article IV is hereby added to the Articles of Organization to read as follows:
