ARTICLE I

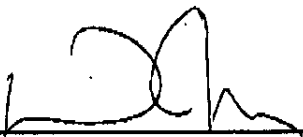

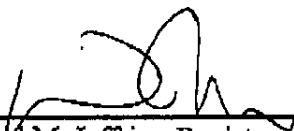
