ARTICLES OF ORGANIZATION
for
DUNN- FLORES DEL RIO, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be Dunn- Flores del Rio, LLC ("Company").

ARTICLE II - STREET ADDRESS


