The name of the Limited Liability Company is MSJMT HOLDINGS, LLC (the "Company").

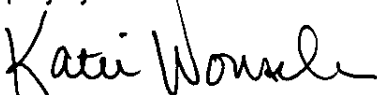

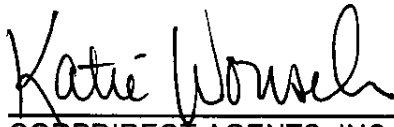
