### ARTICLES OF ORGANIZATION OF 672-MIRABELLA, LLC

a Florida Limited Liability Company

The undersigned member of a Limited Liability submits these Articles of Organization for the purpose of becoming a Limited Liability Company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. # ARTICLE V OFFICERS

The Member/Managers of the Limited Liability Company may appoint such officers, and delegate rights and powers to manage, to such officers as desired.

#### ARTICLE VI

#### MEMBERSHIP RESTRICTIONS

Members shall have the right to admit members upon consent of a majority of members of the Limited Liability Company.

A member's interest in the Limited Liability Company may not be sold or otherwise transferred except with written consent of a majority of members of the Limited Liability Company.

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event that terminates the continued membership of a member in the Limited Liability Company, the remaining members shall have the right to continue the business on unanimous consent of the remaining members.
