Article I

The name of the limited liability company ("Company") is BASS KAT, LLC.

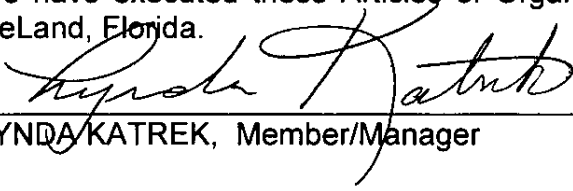
Article VII
