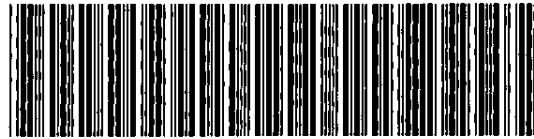

This matter came before the Court at a hearing held on December 16, 2011, on Plaintiff's Motion for Final Judgment as to Count I - Dissolution and Appointment of Receivers, and the Court having heard argument of counsel and being otherwise fully advised on the premises, it is hereby ORDERED AND ADJUDGED as follows:

Pursuant to Fla. Stat. § 608.4493, the Florida Department of State is hereby instructed to dissolve Tropical Koi and Water Gardens, LLC, a limited liability company, effective this 16th day of December 2011, due to the misappropriation and wasting of Tropical Koi's assets by Mr. Jamie Mendoza, a managing member of Tropical Koi. It is further noticed to all creditors and claimants of the limited liability company that the winding up and liquidation of Tropical Koi's business and affairs, including the distribution of the assets of the limited liability company, is moot due to the apparent abscondence of Mr. Mendoza with any and all remaining assets of the limited liability company.
