**ARTICLES OF ORGANIZATION
OF
GBH MANAGEMENT PARTNERS, LLC**

1. Name. The name of this limited liability company is **GBH MANAGEMENT PARTNERS, LLC**, a Florida limited liability company (the "Company").

2. Duration. The Company's existence shall commence and be effective as of January 26, 2011 and shall thereafter have perpetual existence.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. Place of Business. The mailing and street address of the Company's principal office is 401 East Jackson Street, Suite 1700, Tampa, Florida 33602, ATTENTION: Joseph Rugg.

5. Registered Agent and Office. The initial registered office of this corporation shall be located at 401 East Jackson Street, Suite 1700, Tampa, Florida 33602 and the initial registered agent of this corporation at such office shall be Joseph Rugg. The Company shall have the right to change such registered agent and such registered office from time to time, as provided by Florida law.

6. Contributions to the Company. No cash or property (other than cash) has been contributed to the Company by its members at this time. No contributions have been agreed upon.

7. Additional Members. Additional members to the Company may be admitted, but only upon the consent of the members of the Company at the time admission is sought.

8. Termination of Membership. Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the Company shall be dissolved unless all remaining members agree in writing to continue the business of the Company.

9. Management of the Company. The Company shall be manager-managed in accordance with the operating agreement adopted by all of the members. The initial manager shall be **AMIR GLOGAU**. Until and unless changed in accordance with the operating agreement, **AMIR GLOGAU** shall have full power and authority to act for and on behalf of the Company, including, without limitation, to enter into contracts, open and close bank accounts, incur and pay debts and expenses, file papers with the Internal Revenue Service, and engage consultants, managers, professionals, and other advisors, and all persons may rely on these Articles of Organization to deal directly with this named individual and the persons he designates on all matters relating to the Company.
