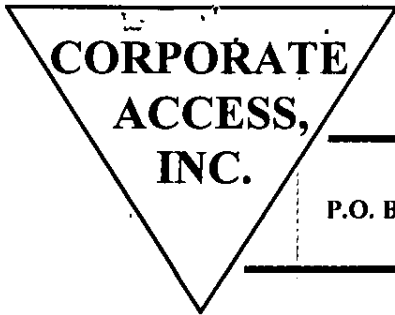


**ARTICLE V


