These Articles of Organization of WILD IDEAS CONSULTING, L.L.C., are being duly executed and filed to form a limited liability company pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes. (the "Act").

#### **ARTICLE I**

#### **Name**

The name of the limited liability company (the "Company") formed hereby is:

#### **ARTICLE II**

#### **Address of Principal Office**

The mailing and street address of the Company's principal place of business in the State of Florida is 331 Anclote Road, Tarpon Springs, Florida 34689.

#### **ARTICLE III**

### **Date of Existence and Duration**

The period of duration of the Company shall begin on the date hereof and continue perpetually.

#### **ARTICLE IV**

#### **Address of Registered Office**
