**ARTICLES OF ORGANIZATION OF  
ERW OF PENSACOLA, LLC**

The undersigned, ELIZABETH R. WOOLF, a natural person competent to contract and member of ERW OF PENSACOLA, LLC, hereby presents these Articles of Organization as the Articles of Organization of ERW OF PENSACOLA, LLC, a limited liability company formed under the provisions of Chapter 608, Florida Statutes.

**ARTICLE I - NAME**

The name of the limited liability company is:

ERW OF PENSACOLA, LLC

This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The mailing and street address of the principal office of the Company is 100 W. Gadsden Street, Pensacola, Florida 32501.

**ARTICLE III - PURPOSES AND POWERS**

This Company is organized for any legal and lawful purpose for which a limited liability company may be organized and may exercise all powers and rights which a limited liability company may exercise under the Florida Limited Liability Company Act.

**ARTICLE IV - COMMENCEMENT AND TERM OF EXISTENCE**

The date for commencement of the Company's existence shall be the date these Articles of Organization are filed with the Florida Secretary of State. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.

**ARTICLE V - REGISTERED OFFICE AND AGENT**

The address of the registered office of the Company is 100 W. Gadsden Street, Pensacola, Florida 32501, and the name of the registered agent at that address is Elizabeth R. Woolf.

**ARTICLE VI - MANAGEMENT**

The Company shall be managed by its members in accordance with the terms of the Operating Agreement of the Company. The name and address of the initial member are as follows:

**ARTICLE VII - RESTRICTION ON MEMBERSHIP**




