Pursuant to the provisions of Chapter 608, Florida Statutes, **CAMP KEYSTONE, LLC** (the "Company") has adopted the following Articles of Amendment to its Articles of Organization.

FIRST: The name of the Company is:

SECOND: The Articles of Organization were filed by the Company on January 31, 2011 and assigned document number L11000012395.

THIRD: The following amendment to the Articles of Organization has been adopted by the Company:

Article V, in its entirety, of the Articles of Organization of the Company be and hereby is revoked, declared null and void and of no further effect and, in lieu thereof, the following Article V is adopted, approved and ratified:

"ARTICLE V

The manager may appoint individuals with such other officer titles as it may select, including the titles of President, Vice President, Treasurer and Secretary, to act on behalf of the LLC, with such power and authority as the manager may delegate to any such individual.
