ARTICLES OF ORGANIZATION OF GOPHERBROKE LLC

The undersigned, under the provisions of Chapter 608 of the Florida Statites the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, does set forth the following:

ARTICLE I - Name

The name of the limited liability company is **GOPHERBROKE LLC** (the "Company").

ARTICLE II - Period of Duration

Unless earlier terminated under the Act or the Operating Agreement, the period of duration of the Company shall be perpetual.

ARTICLE III- Purpose

The managers will be designated as the president, secretary and treasurer of the Company, and may also be designated as vice presidents, assistant secretaries and assistant treasurers, and shall have the authority normally associated with these positions under corporate law. The Company may also designate persons as directors under the Operating Agreement who shall act in a manner similar to the directors of a corporation. The members, at a meeting of the members held not less than annually, shall designate the managers, who may also be
