ARTICLES OF ORGANIZATION

for

NOVA BUSINESS SOLUTIONS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be Nova Business Solutions, LLC ("Company").

The company shall indemnify its members, managers, officers, employees, and agents to the full extent permitted by law.
