Continuation of Business

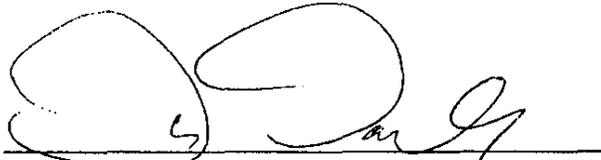

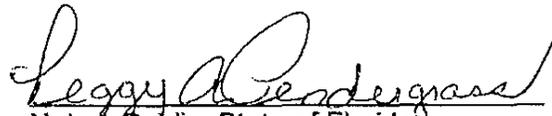

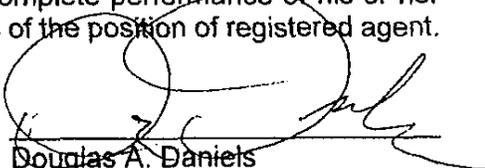
