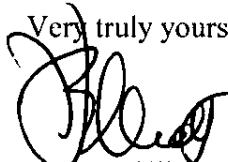

ARTICLES OF ORGANIZATION

OF

ARTICLE I

Name

Subject to any restrictions imposed by law of the Regulations of the Company, the Board of Directors may exercise all of the powers of a Manager under the Act. Any action by the Board of Directors shall be deemed to be an action by the Managers of the Company for the purposes of the Act or otherwise. Admission of Additional Members

Any New Member will be entitled to all of the same rights and privileges as the original Member. The terms of such admission and the capital contributions of any newly admitted members will be determined by the existing Members.

ARTICLE VII

Members' Rights to Continue Business

In the event there is more than one Member, upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member, the surviving and/or remaining Members shall have the right to continue the Company or to terminate and liquidate the Company.

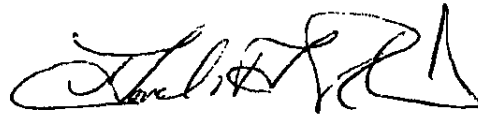
