

ARTICLES OF ORGANIZATION FOR

MCF FLORIDA II, LLC

1. ARTICLES OF ORGANIZATION.

ARTICLE I NAME

The name of the Limited Liability Company is as follows:

MCF FLORIDA II, LLC

ARTICLE II ADDRESS
