**ARTICLES OF ORGANIZATION OF  
TAW INTERNATIONAL, LLC**

The undersigned authorized representative of the Member, as defined below, pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby submits the following Articles of Organization:

**ARTICLE I. NAME** - The name of the limited liability company shall be TAW International, LLC (the "Company").

**ARTICLE II. MEMBER** - The initial sole member of the Company is TAW Miami Service Center, Inc. (the "Member").

**ARTICLE III. DURATION** - The period of the Company's duration shall commence on the date of filing of these Articles of Organization and shall exist perpetually, unless terminated in accordance with the Company's operating agreement.

**ARTICLE IV. PURPOSE** - The purpose for which the Company is being formed is to engage in any activity or business permitted under the applicable laws.
