- SECOND:** The Articles of Organization were filed on February 10, 2011 and assigned document number L11000017759.
- THIRD:** The date of the adoption of these Articles of Dissolution is 26 June 2014.
- FOURTH:** The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 605.0709.
