**ARTICLES OF DISSOLUTION OF FIGS AND OLIVES COMMUNICATIONS, LLC, A

FIRST: The name of the Company is FIGS AND OLIVES COMMUNICATIONS, LLC.

SECOND: The effective date of dissolution of the Company is June 2, 2011.

SIXTH: There are no suits pending against the Company in any court.


