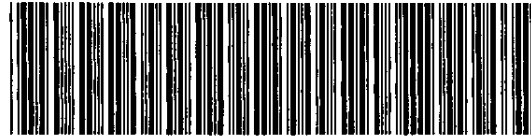

**SECOND:** The date of filing of the Articles of Organization of the Company (the "**Articles**") was February 14, 2011 under Document Number L11000019471.


**THIRD:** The following amendments to the Articles have been adopted by the Company:
