The business and affairs of the limited liability company shall be managed by one or more Managers elected as provided in the Regulations of the limited liability company.


2. The Articles of Organization of this limited liability company were duly filed with the Florida Department of State on February 15, 2011, and assigned Document Number L11000019978.

5. This amendment shall be effective immediately upon filing.


