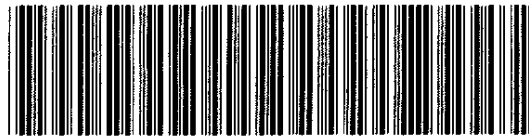

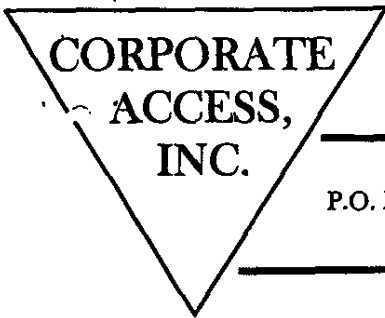

**ARTICLES OF ORGANIZATION
OF

The undersigned, being the Member and Organizer of the Limited Liability Company hereby being formed under Florida Statutes, §§ 608.401 to 608.471, do hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST, the name of the Limited Liability Company is:

ROBERT WILLIAMS PROPERTY MANAGEMENT, L.L.C.

SECOND, the latest date on which the Limited Liability Company is to dissolve is March 1, 2061.

THIRD, The Limited Liability Company is organized to acquire and manage real property, for which a limited liability company may be organized in accordance with Florida Statutes, §§ 608.401 to 608.471, including all powers and purposes now and hereafter permitted by law to a limited liability company.

FOURTH, the street address of the initial registered office of the Limited Liability Company in Florida is: 643 Doral Lane, Melbourne, Florida 32940 and the name of the initial registered agent of the Limited Liability Company in Florida at the address is **ROBERT W. WILLIAMS, TRUSTEE OF THE ROBERT W. WILLIAMS REVOCABLE TRUST U/D/T DATED JUNE 6, 1995.**

FIFTH, the mailing address and principal office of the Limited Liability Company is 643 Doral Lane, Melbourne, Florida 32940.

SIXTH, the Limited Liability Company is to be managed by a Managing Member. The name and address of the initial Managing Member is: **ROBERT W. WILLIAMS, TRUSTEE OF THE ROBERT W. WILLIAMS REVOCABLE TRUST U/D/T DATED JUNE 6, 1995**, having an address at 643 Doral Lane, Melbourne, Florida 32940.

SEVENTH, the total amount of cash (and a description and agreed value of any property other than cash) contributed to the Limited Liability Company, as capital, by the Member is \$25,000.00. The Member contributed the amount set forth below:

The allocations and distributions of the Limited Liability Company shall be made in proportion to the Member's Percentage Interests.

EIGHTH, additional capital contributions may be made at such times and in such times and in such amounts as may hereafter may be agreed by the vote of the single Member. No additional capital contributions have been agreed to by the Member at this time.

NINTH, the existing Member shall have the right to admit additional Members to the Limited Liability Company by the vote and consent of the initial single Member.

TENTH, the remaining Member of the Limited Liability Company, by the unanimous vote or consent of the Member (other than the Member who caused the Withdrawal Event), may continue the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Limited Liability Company.

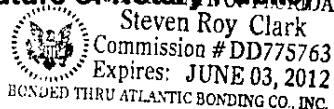
