**ARTICLES OF ORGANIZATION
OF

The undersigned, JON RAY BUSBY and TAMMY WYNELL WILEY, natural persons competent to contract and members of BREEZE SPECIALTIES, LLC, hereby present these Articles of Organization of BREEZE SPECIALTIES, LLC, a limited liability company formed under the provisions of Chapter 608, *Florida Statutes*.

ARTICLE I

The name of the limited liability company (referred to hereinafter as the "Company") is as follows:

ARTICLE II - PRINCIPAL OFFICE ADDRESS

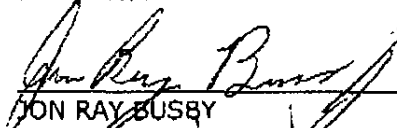

ARTICLE VII - AMENDMENT

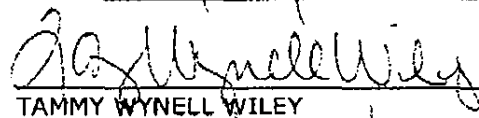

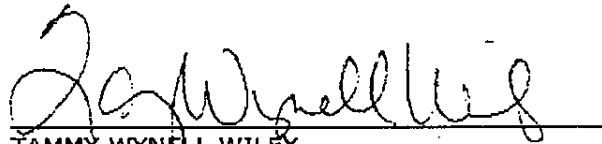
