



**ARTICLE I -- NAME**



## **ARTICLE V - EFFECTIVE DATE AND DURATION**

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Secretary of State or on another effective date as specified. The Company's existence shall be perpetual unless the Company is dissolved earlier as provided in these Articles of Organization or in the Operating Agreement.

## **ARTICLE VI - PURPOSE**

The purpose for which the Company is organized is to operate a business for any lawful purpose.

## **ARTICLE VII - ADMISSION OF NEW MEMBERS**

Except as set forth in the Operating Agreement, no additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the Operating Agreement of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

## **ARTICLE VIII - MEMBERS' RIGHT TO CONTINUE BUSINESS**

The Members of the Company shall have the right to continue the business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or occurrence of any other event which terminates the continued membership of a Member in this Company. Continuation shall occur pursuant to the terms of the Operating Agreement of this Company and with the vote of members holding a majority of the then issued and outstanding Membership Units.


## **ARTICLE IX - MANAGEMENT**

The Company shall be managed by Managers, in accordance with the Operating Agreement for the Company adopted by the members for the management of its affairs. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles.
