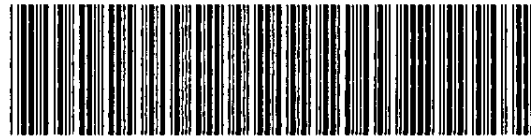

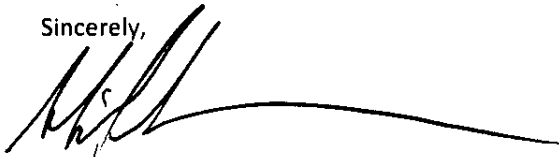

**Articles of Organization
of
Tewem Services, LLC**

The undersigned, for the purposes of forming a limited liability company pursuant to the Florida Limited Liability Company Act, Chapter 608, Fla. Statutes, certifies;

**Article I
Name**

The name of the limited liability company is Tewem Services, LLC. The principal office and mailing address of the company is 711 Canadice Lane, Winter Springs, FL 32708.

**Article II
Duration**

The duration of this limited liability company shall be perpetual.

**Article III
Purpose**

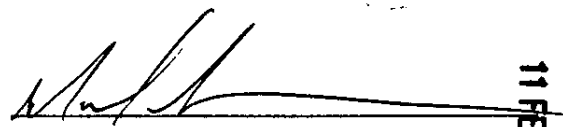
