FIRST: The Articles of Organization were filed on February 17, 2011, and assigned document number L11000020845.


SECOND: Article 1 of the Articles of Organization shall be deleted in its entirety and the following text was adopted by the limited liability company as the new Article 1 to its Articles of Organization:
