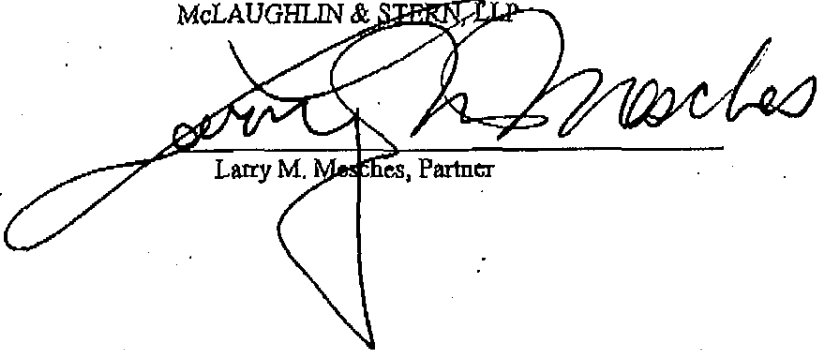
ARTICLE III

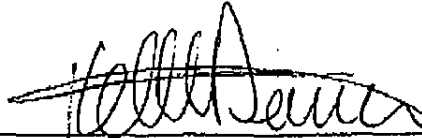
