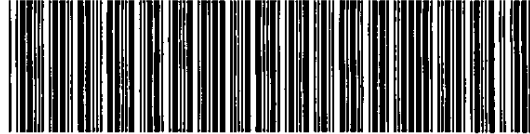


Mr. Jonas Vencius investment in the business was bought out by the company, the check was cashed and he has no affiliation with the company effective August 8, 2016.


