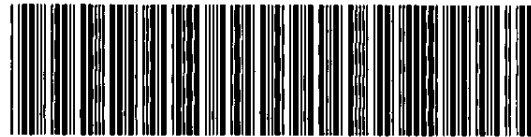

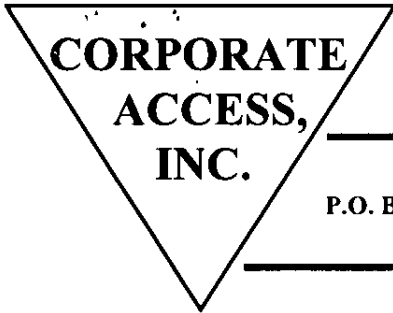

ARTICLE VIII - AMENDMENT


