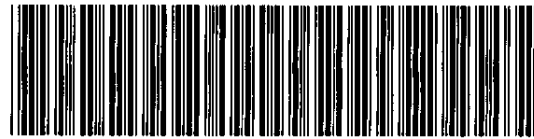

ARTICLE VII INITIAL REGISTERED OFFICE AND REGISTERED AGENT




