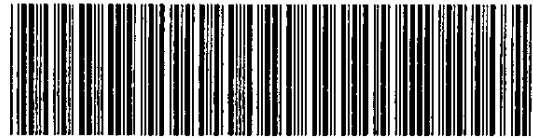



**ARTICLES OF ORGANIZATION
OF
PETERSON OSBORNE HARTER, LLC**

1. Name. The name of this limited liability company is PETERSON OSBORNE HARTER, LLC, a Florida limited liability company (the "Company").

2. Duration. The Company shall have perpetual existence commencing on the filing of the Articles of Organization with the State of Florida and continues even though a membership of a member is terminated.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida, including, but not limited to, the right to purchase, develop, own, sell and lease real estate, construct improvements, and list real estate for sale or lease and engage in business and such other lawful activities as are reasonably necessary, convenient or incidental to these purposes.


8. Voting. The Company is authorized to issue membership interests with voting rights and membership interests without voting rights.

Operating Agreement of the company as defined in section 608.402(24) of the Florida Statutes must be in writing and signed by the initial member.


